CONDITIONS OF TICKET REBATE PROGRAM:

To qualify for a rebate from this program the following must be meat:

- 1. Registration form must be returned within 30 days of purchase.
- 2. Registered owner of a radar and laser defense product does not exceed 15 miles per hour OR 30% over the posted speed limit, whichever is less.
- 3. The ticket must clearly state 'RADAR' or 'LASER' and "SPEEDING".
- 4. Rebate only valid in the USA.
- 5. Registered owner must be the driver of the vehicle when ticket is issued.
- 6. Registered owner is qualified for this program for one full year from date of purchase.
- 7. Only the person who is the registered owner of a radar and laser product is eligible for the rebate

- 8. Does NOT APPLY where DWI or DUI is involved or in school, double fine, or construction zones.
- 9. This rebate is not available in California.
- 10. Does not apply if registered owner received a citation for speeding 60days or less from the date of purchase, or received two or more speeding tickets in any 6 month period, Rebate is limited to a maximum of 2 speeding tickets.
